

NEW HANOVER COUNTY BOARD OF EDUCATION

ADDENDUM #1 TO SUPERINTENDENT'S CONTRACT

THIS ADDENDUM (Addendum #1) dated August 15, 2023, is between the NEW HANOVER COUNTY BOARD OF EDUCATION, hereinafter sometimes called "Board", and DR. CHARLES FOUST, hereinafter sometimes called "Superintendent";

W I T N E S S E T H:

WHEREAS, the Board and Superintendent entered into a contract dated July 31, 2020 for employment of the Superintendent as Superintendent for New Hanover County Schools; and

WHEREAS, on August 15, 2023, the Board voted to amend said contract. extending it until June 30, 2027 and;


NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, the parties agree as follows:

1. Effective August 15, 2023, the term of the contract is extended until June 30, 2027.
2. Except as expressly amended in this Addendum #1, the contract between the parties shall remain in full force and effect.
3. This Addendum #1 shall not be amended except in writing signed by both parties.
4. This Addendum #1 shall be construed in accordance with the laws of the State of North Carolina.
5. This Addendum # 1, and the contract between the parties dated July 31, 2020, contain the entire agreement between the parties. There are no terms to said contract except as expressly stated in said contract, this Addendum #1, or required or implied by law.

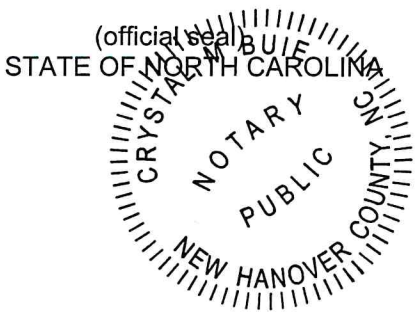
